Identity Verification Form

The student has three options for providing documentation of identity – “In Person” (A), “By Mail” (B), or “By Video Conference Call” (C). This form may NOT be faxed or emailed and must be presented/submitted along with acceptable documentation.

A. “In Person” Verification:

The student must appear in person at the Viterbo University Financial Aid Office (Murphy Center – Room 218) and present an original, unexpired, valid government-issued photo ID, such as a driver’s license, other state-issued ID, or passport. The Financial Aid Office will make a copy of the ID for the student’s financial aid record, witness the student signature in Section D of this form, and complete Section F.

B. “By Mail” Verification:

The student must present a Notary Public with an original, valid government-issued photo ID (acceptable variations identified in Section A). The Notary will witness the student’s signature in Section D and complete Section E. Student will mail this completed form, along with a copy of the government-issued ID witnessed by the Notary, to the Viterbo University Financial Aid Office.

C. “By Video Conference Call” (e.g. Zoom or Microsoft Teams):

Student may schedule a Zoom or Teams call with someone from the Viterbo Financial Aid Office (FAO) and present the acceptable identification to the FAO Team Member. The video call option will require the institution to maintain a copy (electronic or hardcopy) of the identification document that includes the date it was presented and the name of the authorized representative that reviewed and approved the documentation. This can be accomplished through a screenshot of the video call that has legible details of the identity document.
